The meeting was called to order and a quorum established. The invocation was led by Alderman Donald Burris and the pledge was performed by Mrs. Byrd's sign language group from Folsom Elementary School.

The Agenda was approved on motion of Alderman Burris, seconded by Alderwoman Mathies. (3 Yeas, 0 Nays) The motion carried.

**Item No. I Engineer's report** – no representative present.

**Item No. II Comprehensive Plan report** – Mr. Villavaso reported that the Master Plan had been adopted by the Planning Commission and needs to be ratified by the board of aldermen. Also reported was the official census count for the village of 716 residents and this information will be incorporated into the Plan. Mr. Villavaso reported that the zoning ordinance draft has been distributed to the Zoning Commission as well as the Technical Advisory Board which will meet tomorrow night to go over the text and map. On motion of Alderwoman Mathies, seconded by Alderman Willie the Master Plan that was adopted by the Planning Commission was accepted. (3 Yeas, 0 Nays) The motion carried.

**Item No. III Request for revocation of portion of alley in Square 135 Petitioner: Linda Vining** – On motion of Alderman Burris, seconded by Alderwoman Mathies this matter was tabled until next month so that all pertinent information is gathered. (3 Yeas, 0 Nays) The motion carried.

**Item No. IV Greg Saurage re: Mardi Gras** – Mr. Saurage announced the Queen of Mardi Gras – Mrs. Audrey Rosier, King of Mardi Gras – former mayor Marshall Brumfield and this year's parade dedicated the Mrs. Evelyn Pittman.

At this time a question was posed as to allowing confederate flags to be displayed in the parade. Mayor Bickham stated he would address the issue with Mr. Saurage.

**Item No. V Appointments to sign check** –at this time Mayor Bickham appointed Alderwoman Jill Mathies, Alderman Donald Burris, Joyce Core , Clerk and himself as signees on the bank accounts.

**Item No. VI Resolutions authorizing Mayor Bickham to sign grant applications on behalf of the Village of Folsom** – on motion of Alderman Burris, seconded by Alderman Willie authorization was given for Mayor Bickham to sign grant applications on behalf of the Village of Folsom. (3 Yeas, 0 Nays) The motion carried.

**Item No. VII Request for Class B Beer and Class B Liquor license Petitioner; The Tobacco Shak Plus** – no representative present.

There being no further business, the meeting was adjourned on motion of Alderman Burris, seconded by Alderman Willie. (3 Yeas, 0 Nays) The motion carried.
